



Corrective Action Request

Web EHSdesk™ provides a fully integrated suite of web-based software modules designed to support administrative, operational, and business process information management associated with Environment, Health, and Safety (EHS).

The **Corrective Action Request (CAR)** module offers a systematic process for tracking the tasks necessary to perform corrective action investigations, identify root causes, and implement corrective action plans in a timely manner. Automatic e-mail notifications facilitate timely resolution of tasks required to complete corrective actions. Corrective action requests can be issued and maintained from within other Web EHSdesk modules.

Features and Functionality

- Corrective action requests can be created and maintained for any type of nonconformance item
- Corrective action requests are issued with an automatic plan response due date generated
- Detailed corrective action attributes are documented including: root cause, corrective action plan, nonconformance description, cost information, due dates, and severity
- Multiple nonconformance findings/root causes can be tracked per CAR

Finding Summary Page

- Multiple task items per corrective action plan can be created including assignment to responsible people, due dates, and actual dates
- Approve/reject cycle is available for corrective action plan/response
- Implementation can be documented with the ability to optionally generate follow-up
- Follow-up results can be documented with reject ability
- Typical users include EHS Professionals, EHS Managers, Supervisors, Quality Auditors, and Operations Management
- Simple "Quick Form" interface for defining a CAR plan and closing out tasks

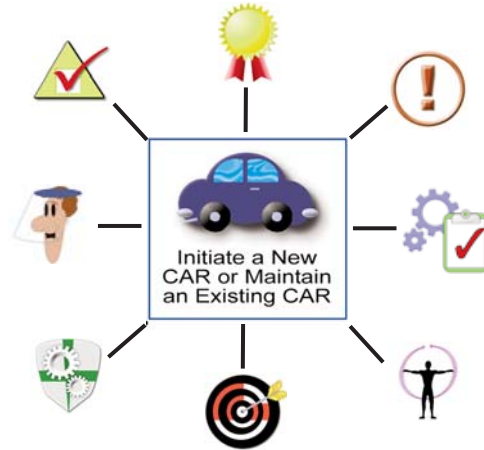

Integration Points

CARs can also be generated in:

- EHSdesk **Ergonomics** - to document an ergonomic problem/fix
- EHSdesk **Incident Tracker** - to document incident investigation
- EHSdesk **Machine Guard** - for a missing or deficient guard
- EHSdesk **Operator PM** - for a missing or deficient preventive maintenance (PM) plan
- EHSdesk **PPE Assessment** - for missing or deficient personal protective equipment (PPE)
- EHSdesk **Risk Assessment** - for a hazard or missing or deficient control
- EHSdesk **Audit & Inspection Management (AIM)** - for a nonconforming checklist answer or general finding
- EHSdesk **Regulation Manager (REG)** - for a finding (e.g., NOV) issued against a regulatory record
